



2024-2025 Professional Development Award

Award amount: Ranges from \$100 - \$500

Application due date: September 19, 2024 by 5:00 pm EST

Professional development activities must occur between September 26, 2024 and June 30, 2025

Purpose

The UNC Network for Research Professionals is proud to announce our 2024-2025 NRP Professional Development Award. This award provides supplemental funding to help cover professional development opportunities for University of North Carolina at Chapel Hill employees or UNC Health employees whose work is focused on Human Subjects Research.

The award covers work-related education and training and can be used for conferences, certificates, continuing education, classes or seminars, or similar instructional opportunities that are not already covered by other resources. Specifically, the award is designed for expenses incurred prior to the opportunity (e.g., registration, materials, travel). Courses for academic credit are not eligible for this award, as those can be accessed through the University's [tuition waiver benefit](#) or UNC Health's [educational assistance benefits](#).

Individual awards ranging from \$100 - \$500 will be granted depending on strength of application.

UNC Network for Research Professionals (NRP)

The UNC-NRP is a peer group that is open to all research personnel engaged in human subjects research to help increase awareness and communication of best practices through a series of educational seminars, resources, mentoring and networking programs.

Eligibility

- 1) Full or part-time permanent employees at the University of North Carolina at Chapel Hill (SHRA or EHRA non-faculty) or UNC Health who have been employed as a Research Professional for at least the past 1 year at the time of this application are eligible for this award.
- 2) Funding must be for individual benefit, relate to the employee's position, and meet a professional development purpose (not departmental).
- 3) Applicant may not have received the UNC NRP Professional Development Award for the same or a different opportunity in the two years prior to the application.
- 4) Applicants must indicate all other sources of funding they are pursuing and/or have already received (e.g., school/departmental funds, Educational Assistance Program, Janet B. Royster Scholarship, etc.).



5) Application must be complete and received by the deadline below.

NRP Steering Committee members that participate on the selection committee are ineligible to receive the award. In the event that a member of the selection committee has a conflict in reviewing an application, the selection committee member will not participate in the review of the specific applicant's file.

All applications must be complete and submitted by the application deadline. Any incomplete applications will not be considered.

Awardees will be notified via email by September 25, 2024.

Requirements for Reimbursement

Funds will be disbursed by the University of North Carolina in the form of a reimbursement after the event or certification exam.

- If the event is a certification exam, you must provide verification that you successfully passed the exam in order to receive reimbursement.
- For other activities, you must provide verification of completion of the activity in order to receive reimbursement.
- In accordance with the [IRS Accountable Plan](#) policy, all reimbursements must be processed within 60 days of purchase to avoidable possible taxation. Travel reimbursements will be based on the trip end date.
- For conference travel, the awardee must follow all appropriate University and/or UNC Health travel policies. Consult your business unit for additional details, as needed.

Awardees must provide the NRP with contact information for their accounting representative within their business unit. The NRP will not directly process any reimbursements, nor will the NRP assist with arranging/approving travel.
